

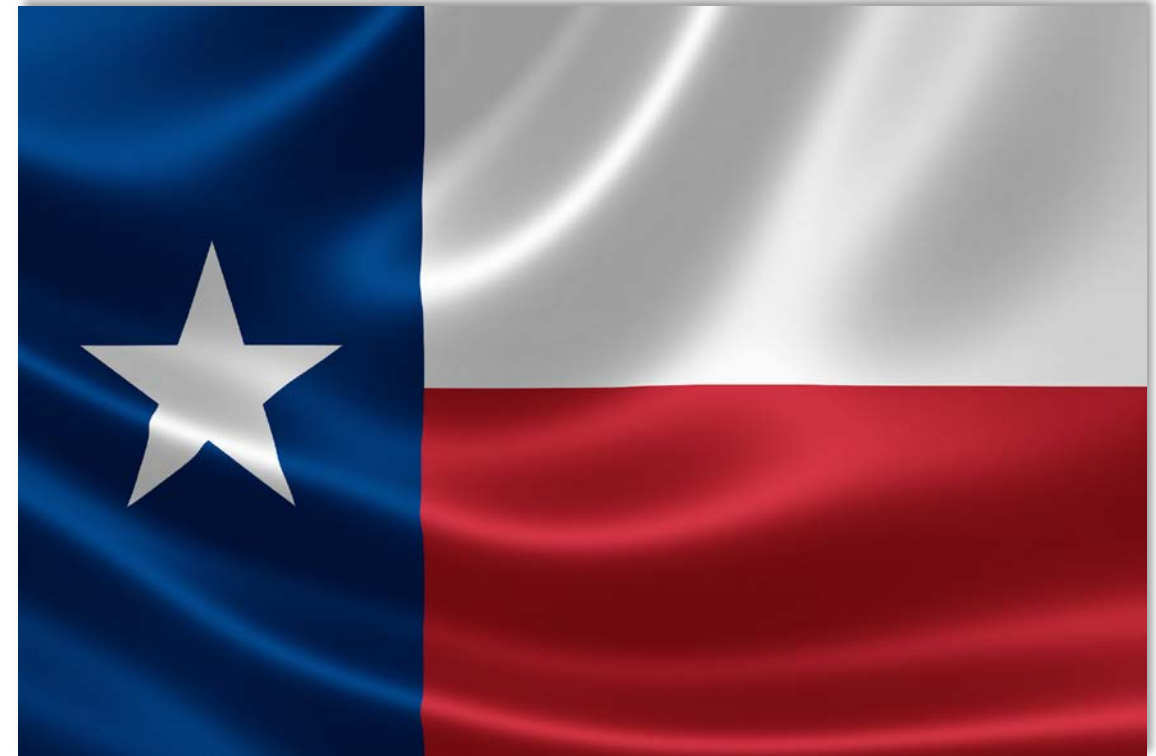

- House State Affairs Committee (June 22-23)
  - Proposed changes to ERCOT market design
  - Implementation of SB 2
  - Weatherization efforts of generation facilities
  - Grid transmission congestion reduction
- Senate Business & Commerce (June 29)
  - Update on broadband infrastructure
  - USF fund
  - Impacts of weather preparedness and natural gas supply chain



# State Energy Plan Advisory Committee (SEPAC)

- SEPAC created by Senate Bill 3 during 87<sup>th</sup> Texas Legislature
- Tasked with preparing a state energy plan that includes recommendations on improving reliability, stability, and affordability
- Committee met June 28 for panel and discussion on many topics, including:
  - Weather and regulatory outlooks
  - Solutions for resource adequacy, dispatchable generation, and transmission and distribution
  - Evaluations on market structure and pricing mechanisms for electricity and natural gas
- Committee will submit recommendations by September 1

- Moved outlook to stable from negative

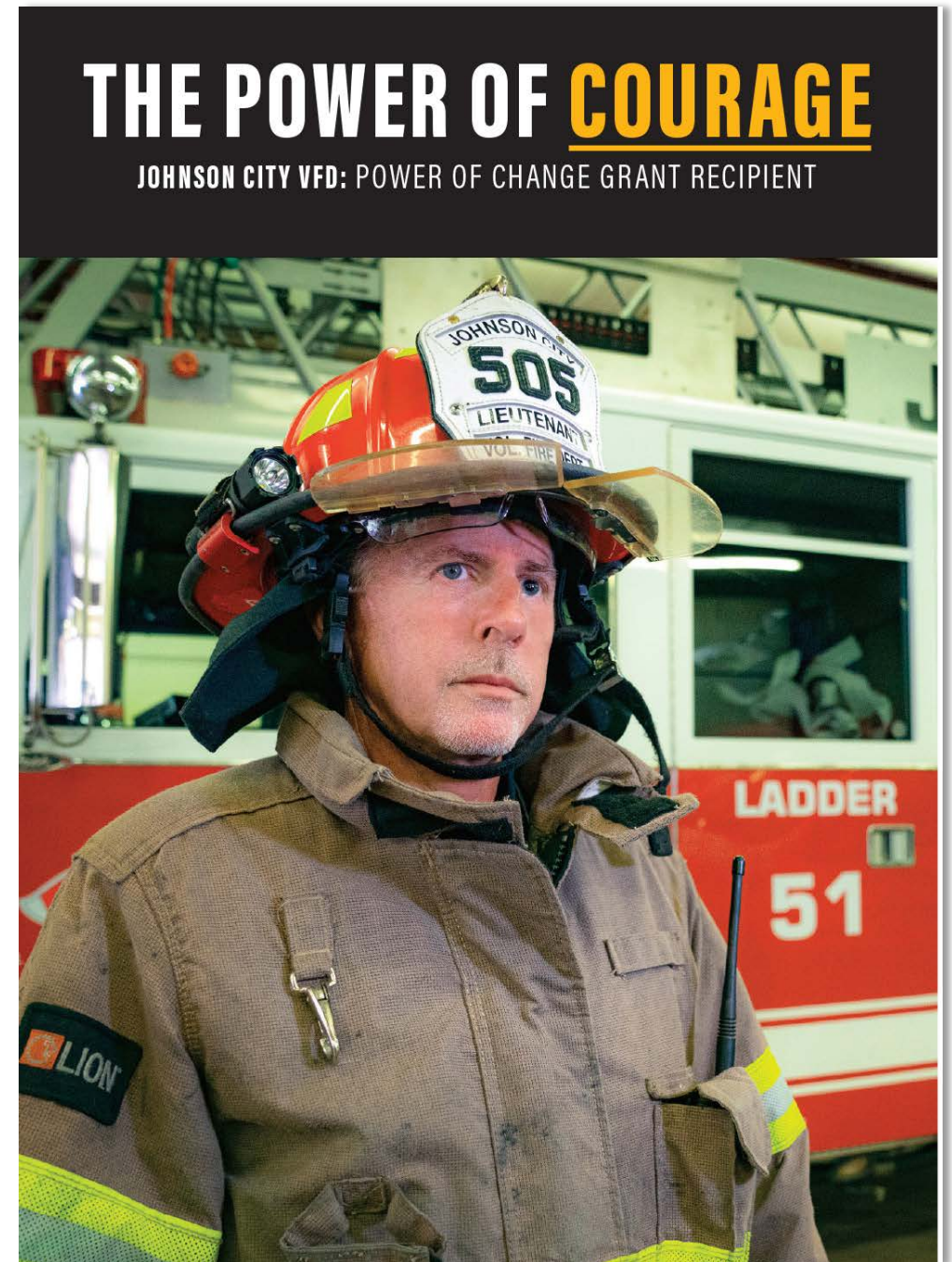
