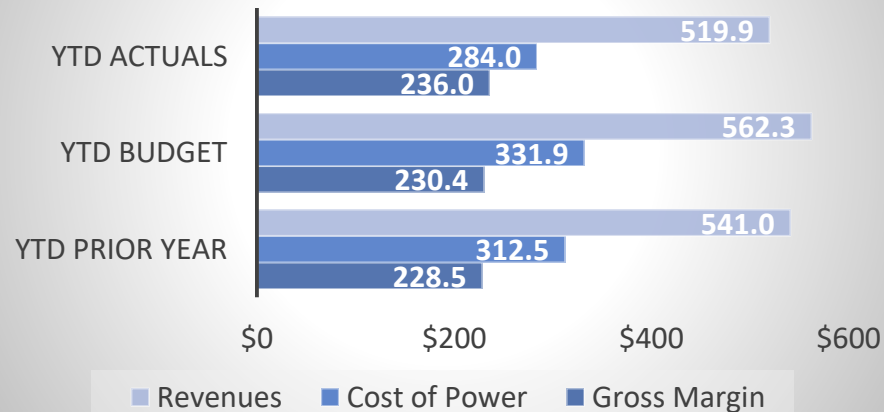

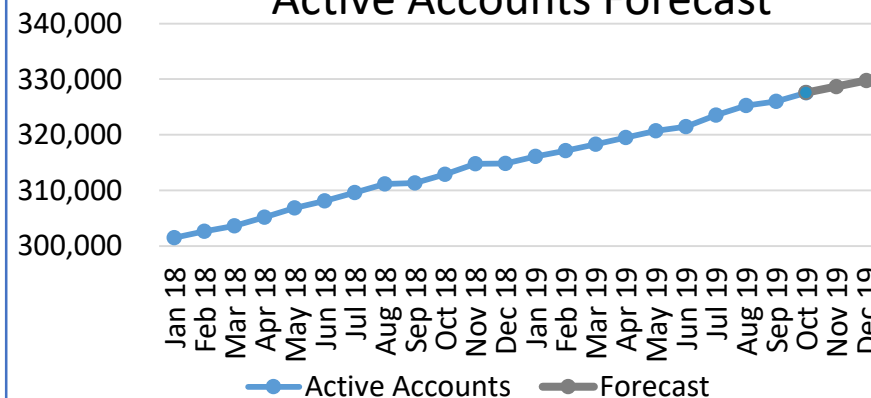

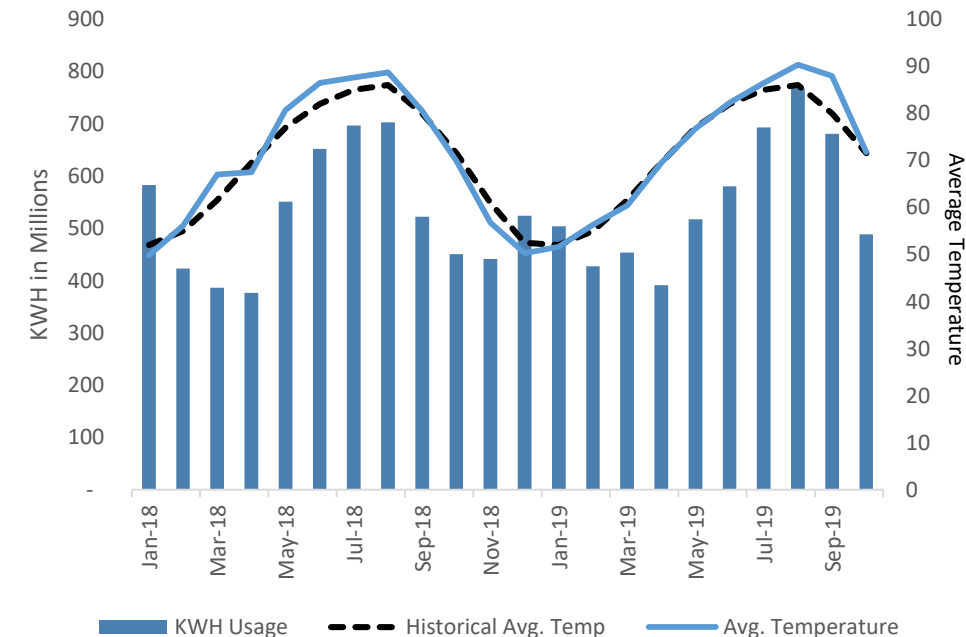

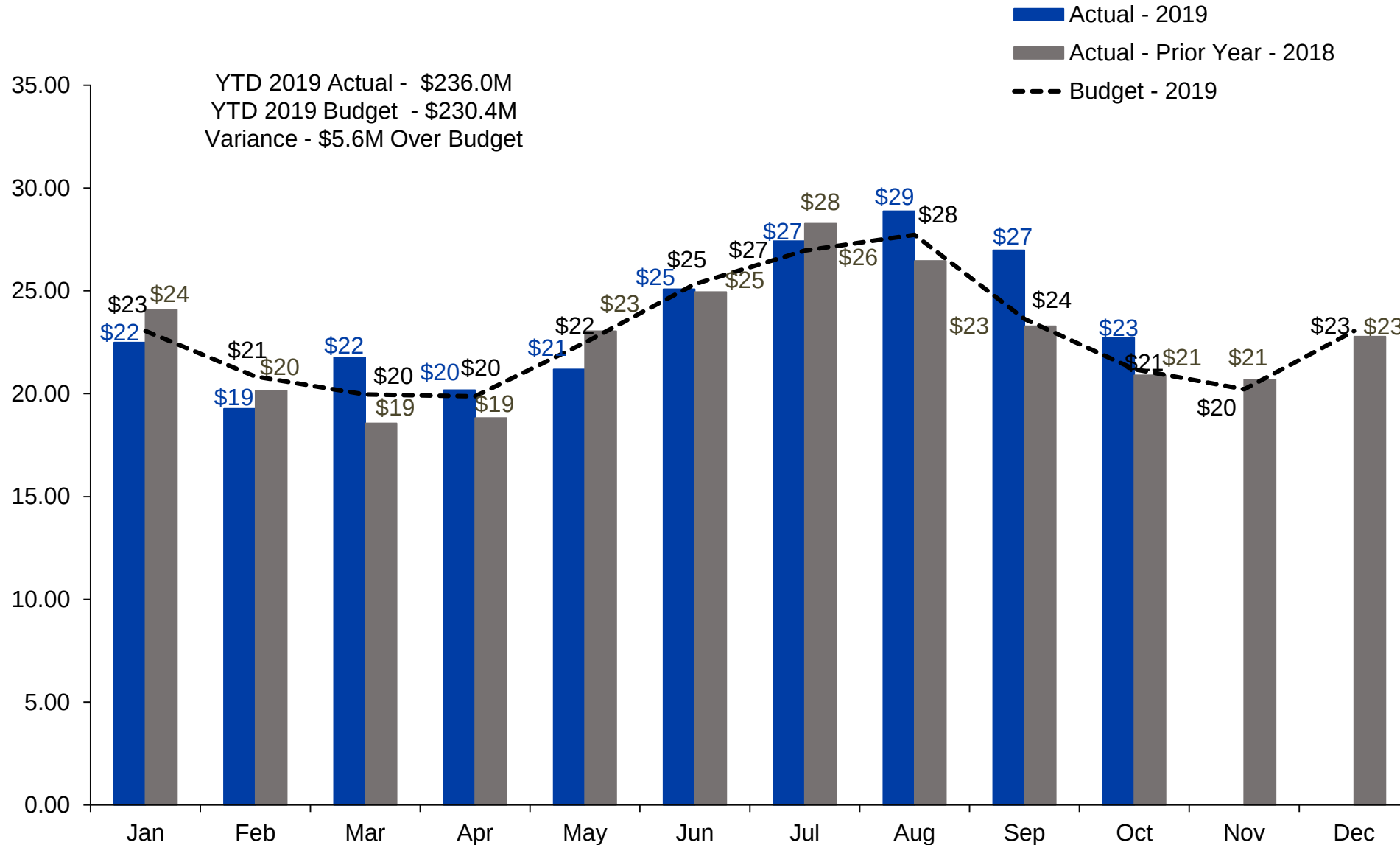

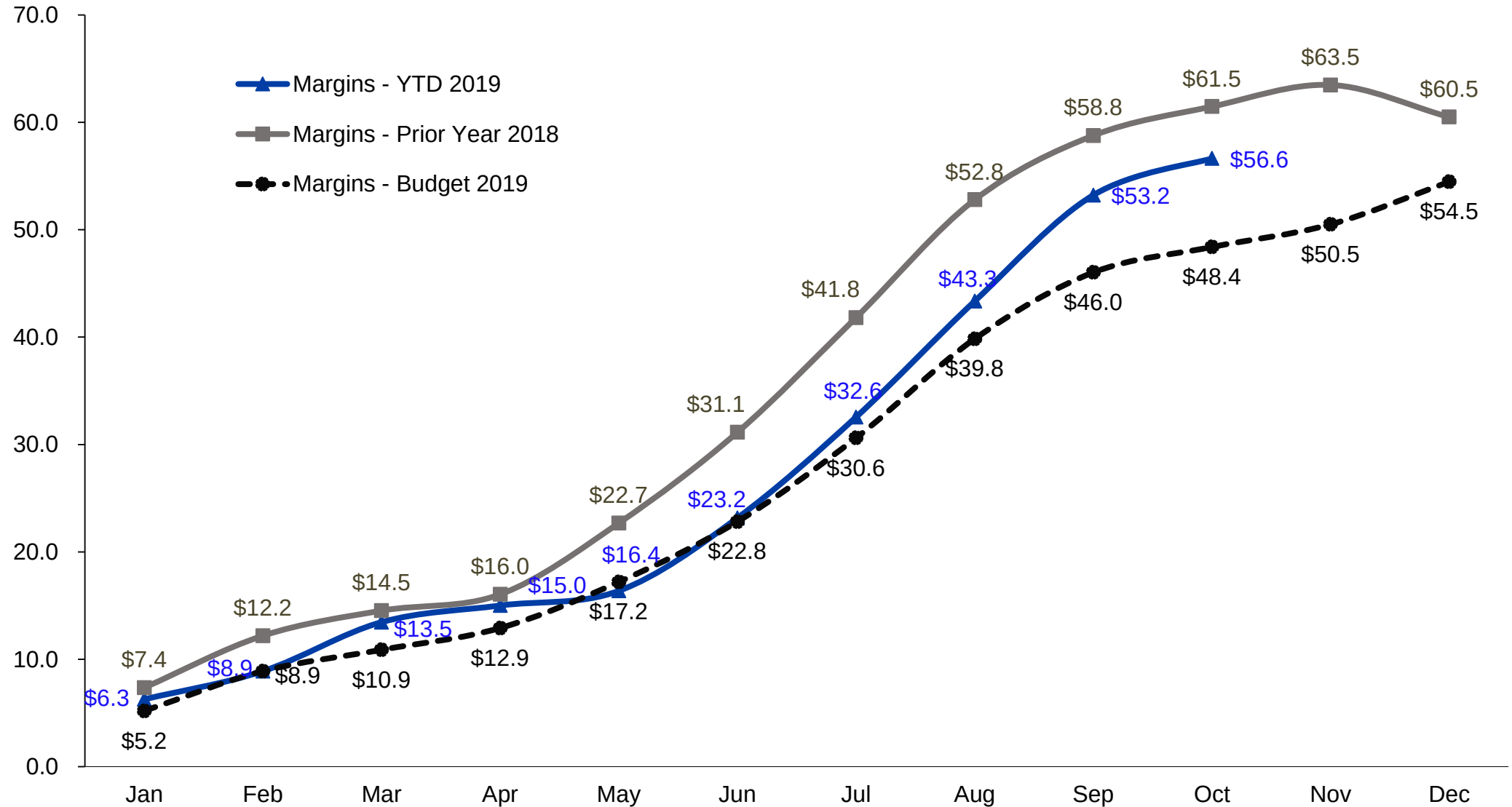

Gross Margins by Month (in millions)

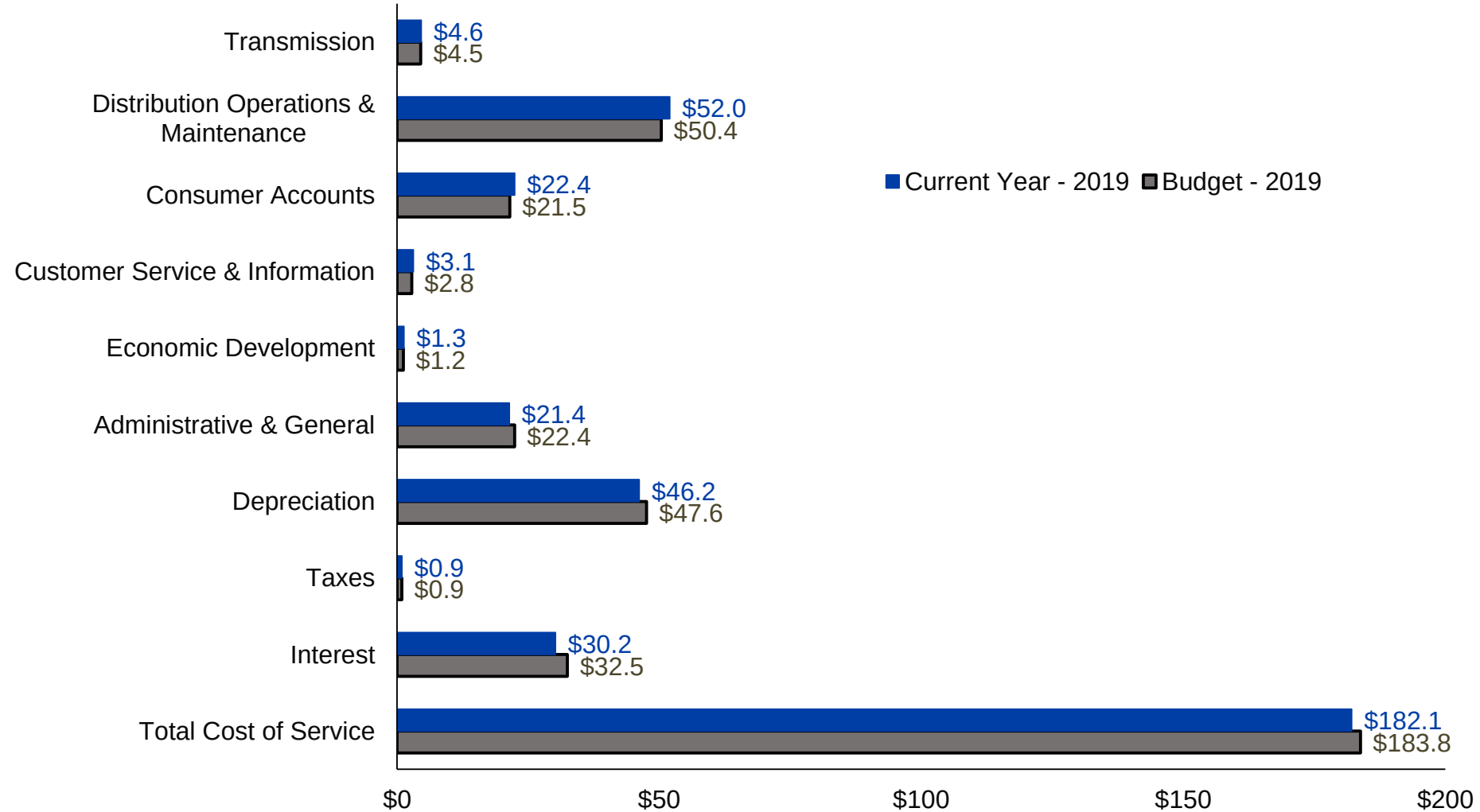


Net Margins Year to Date (in millions)

YTD Actual vs Budget through October 2019

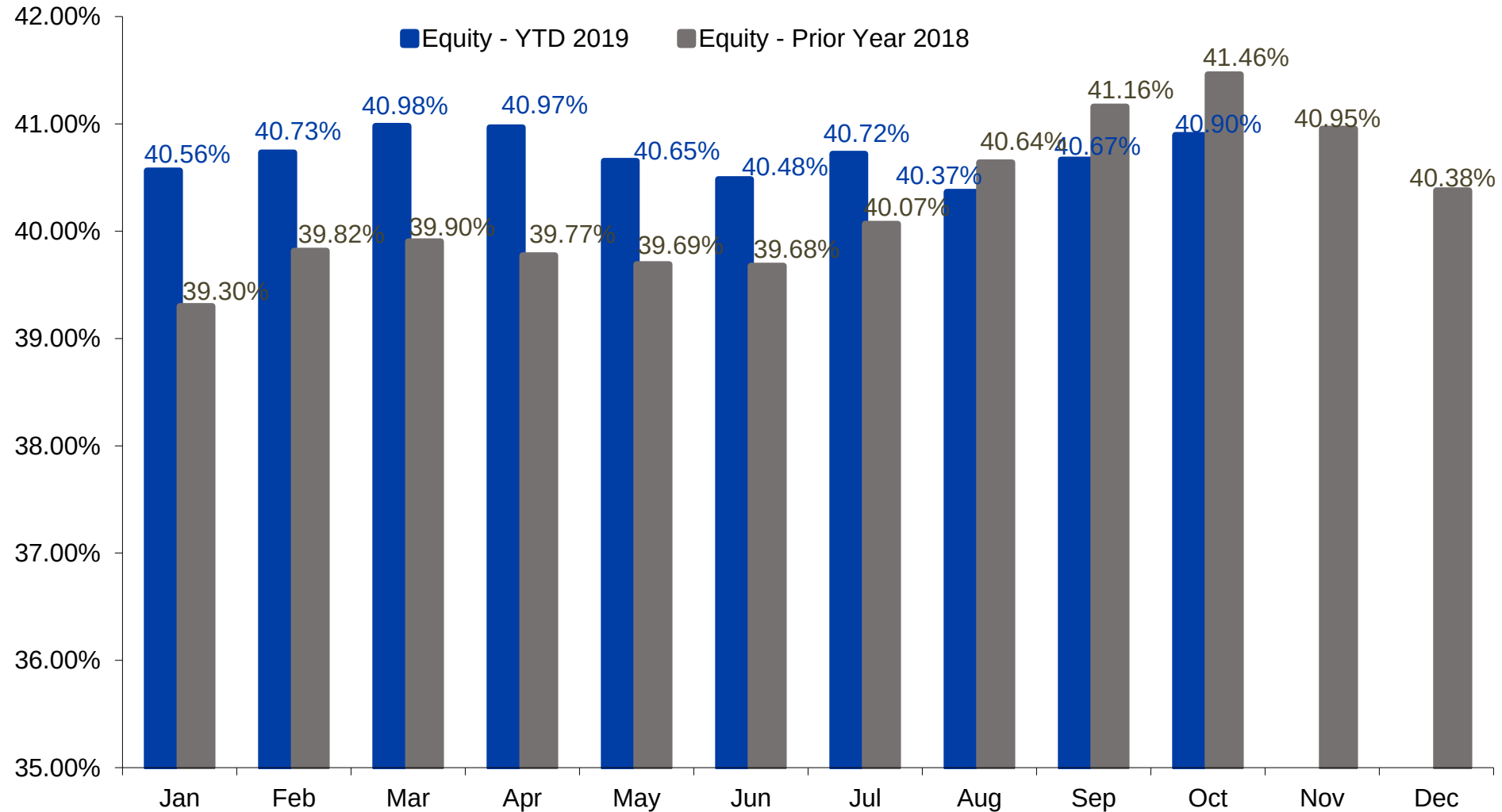
