Regulatory Update: Market Redesign

- Following Winter Storm Uri and legislation passed during the 87th Texas Legislature, the PUC is implementing changes to the energy market in two major phases
 - Phase 1 completed
 - Generation to be brought online earlier and large consumers are incentivized to adjust demand
 - New and revamped ancillary services, which include payments: for onsite fuel storage, for quick response to grid frequency changes, and for ability to react to abrupt demand swings in supply and demand
- Phase 2 of Market Redesign is underway considering mechanisms to incentivize more dispatchable generation; more information expected in mid-November



Legislative Update

- Staff is continuing outreach with legislative delegation and Capitol visits
- Monitoring Interim Charges; expected before the end of November
- Early voting begins: October 24
- Election Day: November 8
- PEC leadership encourages employee participation in this important civic responsibility
 - PEC allows up to two hours to vote early or vote on Election Day



Protect your information

Protect yourself from identity theft! Never toss the following types of information in unsecured trash or recycling bins.

- Personal information (birthdate, Social Security number, etc.)
- Account information
 (account numbers,
 PINs)
- Payment and financial information (including tax forms)
- Child- and schoolrelated documentation
- Usernames and passwords
- Junk mail (the barcode can sometimes contain identifying info)

Employee Facility Security Training

- Employees across the cooperative have completed mandatory security training
- PEC's goal is to keep employees, members, facilities, and assets safe 24/7
- Training covers proper use of security badges, accessing secure gates and doors, plus reporting incidents
