Sustainable Power Credit Rate

Background

- All Members with distributed generation (DG) less than 50 kW receive the Sustainable Power Credit for all surplus generation delivered to PEC's distribution system
- The Sustainable Power Credit is calculated from the 3-year average avoided cost of the following:
 - Energy Cost
 - Ancillary Service Cost
 - Transmission Cost
 - Other if applicable

Sustainable Power Credit Rate

Proposed Rate Change

- Update the Sustainable Power Credit from \$ 0.060005 to \$0.069554 per kWh of Received Energy

Sustainable Power Credit Rate

Financial Impact

- Impact to a specific member will depend on usage patterns
- Members should see an increase in payments of \$0.009549 per kWh of energy

Current number of members (As of August 11, 2023):

- Residential – 10,392 members, 10,606 accounts
- Small Power – 55 members, 76 accounts

Proposed Tariff Amendment

- Update Section 500.1.12, Sustainable Power Credit

Proposed Implementation Timeline and Details

- Send notice of rate change by 1st week of January 2024
- Effective for all bills issued on and after March 1, 2024

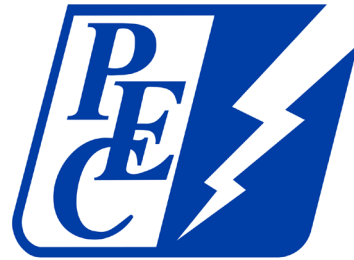
