BOARD OF DIRECTORS COMPENSATION POLICY PEDERNALES ELECTRIC COOPERATIVE, INC.

Policy _____

1. <u>PURPOSEPurpose</u>:

This Policy addresses <u>all</u> compensation<u>and benefits</u> to <u>be paid provided</u> to Directors of the Cooperative for their time and attention in the performance of their duties for the Cooperative.

2. SCOPEScope:

This Policy applies to members of the Board of Directors. <u>The Board of Directors</u> <u>Travel & Expense Reimbursement Policy addresses Director training, travel and</u> <u>expense reimbursements</u>.

3. <u>POLICY ON DIRECTOR COMPENSATIONPolicy Statement and</u> <u>Implementation</u>:

a) <u>3.1 Fixed Monthly Fee.</u> All Directors shall be paid a fixed monthly fee of \$3,000; provided, however, that a Director regularly attends board meetings as provided by this Policy.:

<u>3.1.1</u> if a Director attends less than 75% of any scheduled board meetings (i.e.e.g., regular, special, or called meeting)- during any <u>running-consecutive</u>, <u>rolling</u> 12-month period, that Director shall forfeit the monthly fixed fee, beginning with the next month following the month in which the attendance fell below 75%, until such time as the Director's <u>running-rolling</u> attendance rises above 75% for the yeara consecutive 12-month period; and

<u>3.1.2</u> after one telephonic or electronic participation by a Director per year; any others shall be counted as one-half meeting attendance; and

<u>3.1.3</u> if a Director in person attends less than half of any meeting in person, such attendance shall be counted the same as a telephonic or electronic participation.; and

(1) <u>3.21.4-Nn</u>ewly-elected Directors, who are not current Directors, shall be paid one-half (1/2) the <u>fixed</u> monthly fee for the remainder of month following the <u>Annual Meeting-Director Election</u> at which they are first elected; and the seventy-five percent (75%) attendance policy does not apply until <u>the first</u> beginning-September 1st after their initial election to the Board.

<u>3.23</u> The monthly fee shall be paid regardless of the number of meetings. and/or PEC eventsmeetings, events or functions attended by the Director in any given month, so long as the 75% minimum board meeting attendance level is met.

b) <u>3.4 However, bBy majority vote of remaining Directors for good cause, a</u> Director may be excused for <u>board meeting</u> absence(s). The absence of a Director<u>at board meeting</u> for <u>because of</u> attendance at an <u>Board</u>-approved seminar, educational or training course is an <u>shall be</u> excused <u>absence</u>.

e) <u>3.53</u> The Cooperative does not provide sponsorship of any <u>separate or</u> <u>distinct</u> retirement or healthcare coverage <u>or plan</u> for any former, current or future Director or their dependents, regardless if the cost of such coverage would be paid by the Cooperative or the Director.

<u>3.64- Optional Insurance Coverage</u>. Health, dental and vision insurance coverage that is also available to eligible employees, is provided, on a voluntary basis, to Directors and their dependents so long as the Director serves on the Board of Directors. A Director is solely responsible for the payment of all premium costs for selected coverage(s). Coverage may include access to the Cooperative's High Deductible Health Care Plan and includes any contribution to a Health Savings Account offered by the Cooperative. Group health insurance will be provided, on a voluntary basis, to Directors and their dependents at each Director's own cost, until such time as the Director no longer serves as an active Director.

4. **PROCEDURE RESPONSIBILITIES**Procedure Responsibilities:

a) The Board of Directors is responsible for the procedure and implementation of this policy.

5. **ENFORCEMENT**Enforcement:

a) The Board of Directors implements and enforces this Policy.

6. SUPERCEDING EFFECTSuperseding Effect:

a) This Policy supersedes all previous policies and memoranda concerning the subject matter. Only the Board of Directors Approver may authorize exceptions to this Policy.
