- Increased efficiencies
- Increased test coverage
- Time savings for automated tests
 - Procurement: 5 hours
 - SmartHub: 16 hours
 - DocuVault: 1.5 hours

Automation under development: messenger, accounts payable and service order connects/disconnects



Test Automation


Ideal for repetitive tasks

- Accounts Payable: saves 20 hours/month
 - Automatically rolls the GL post date for unposted invoices to the next GL period
- Plant Accounting (work orders): saves 6 hours
- Automation under development (projected savings)
 - Remittance: 2 hours/day
 - Member Relations: up to 40 hours
 - Mass changes of apartment landlords to/from renters
