
Annual Line Extension Comparison




Line Extensions by District (1,444)








Meter Totals by District (322,292)



Estimated Time of Response (ETR)








- This month highlights Support Services staff; their volume of work, efficient management, and recent trends in payment options

- Despite 18 days of restricted collection activities due to heat, aged balances are in great position compared to last year











Member Relations - Autopay Trending

In early 2019, PEC began offering a deposit waiver for new applicants that enroll in Bank Draft Autopay. The result has been very positive for both PEC and the membership. Automated measures are in place to quickly re-apply deposits when necessary.





Bank draft benefits for PEC:

- Cost-friendly, less than 40% of the transaction fees of credit card payments
- Maintenance-friendly:
 - No credit card expiration dates to monitor and update
 - Does not require member self-enrollment due to PCI restrictions,
 agents can easily set up over the phone if requested


Bank draft benefits for the membership:


- Residential bank draft autopays allow the member to discount their monthly billing:
 - PEC's eDraft Rate: \$1.50 reduction for enrolling in bank draft autopay
 - PEC's eSaver Rate: \$2.50 reduction for enrolling in bank draft autopay and paperless billing

Member Relations - Payment Trending

Additional trends are being monitored with other payment methods:

- Traditional mail-in payments are decreasing and mobile app payments are increasing
- Efforts to transition phone credit card payments to secure self-service options are working well, and have led to a large increase in phone bank draft payments

Transmission Project Updates

- Hwy 32 Wimberley line rebuild and upgrade (Canyon Lake/Kyle)
 - Construction crews mobilized on 7/29/19
 - Poles are on order and will be delivered by 8/15/19
 - Construction complete by early December
- Blanco Devil's Hill distribution under-build re-conductor (Canyon Lake)
 - Rebuild 1.75 miles of transmission line
 - Phase 1: Construction complete for initial phase
 - Phase 2: Pole bid awarded and poles will be delivered in January
- Wirtz Mountain Top line upgrade (Marble Falls)
 - Rebuild 25 miles of 69 kV line and convert to 138 kV
 - Maslonka (contractor) is drilling and setting poles
- Dripping Springs Rutherford relocation (Oak Hill)
 - Relocate 7 poles for Driftwood Golf Club
 - Poles will be delivered by 9/30/19
 - Construction to start in mid-September 2019
- Whitestone Blockhouse Leander line upgrade (Cedar Park)
 - Currently in engineering, pole-bid package to be sent in September 2019.
- Burnet Bertram Andice line upgrade (Bertram)
 - Currently in engineering and evaluating existing easements

Substation Projects

- Andice T1 & T2 Upgrade (Bertram/Liberty Hill) Upgrade T1 & T2 to 46.7 MVA
 - Construction began in May 2019 and scheduled to be completed by October 31, 2019
- Spanish Oak Substation (Liberty Hill/Cedar Park) LCRA to construct substation on the LCRA Round Rock Leander Transmission line
 - PEC to purchase distribution section of the substation
 - Construction started May 2019 and scheduled to be completed in October 2019
- Ridgmar Substation (Liberty Hill) LCRA to construct substation on the LCRA Round Rock - Leander Transmission line
 - PEC to purchase distribution section of the substation
 - Construction started June/July 2019 and to be completed December 2019
- **Esperanza Substation** (Canyon Lake) LCRA/PEC to construct 46.7 MVA substation:
 - Engineering complete in March 2019
 - Construction began in July and scheduled to be completed in November 2019

Substation Projects

- **Leander Substation** (*Cedar Park*) Rebuild 138 kV bus for improved reliability and add line terminal for LCRA transmission line
 - Engineering complete, construction bids received
- **Highway 32 and Wimberley Substations** (Canyon Lake, Kyle) Line terminal work at the substations associated with the transmission line upgrade
 - Engineering complete, construction to start on 9/3/19
- Wirtz, Johnson City, Mountain Top Substations (Marble Falls) Line terminal work at the substations associated with the transmission line upgrade
 - Engineering complete, construction started on 8/19/19
- Crosswinds Substation (Kyle) New substation with one 46.7 MVA power transformer
 - Engineering complete, construction ready to bid
 - Construction to begin in October 2019
- Buttercup Substation (Cedar Park) Upgrade 22.4 MVA power transformer to 46.7 MVA and improve 138 kV bus
 - Engineer selected, project started in August 2019








Vegetation Management








Office:	Activities:
Bertram	Construction for front-office security improvements is underway and the office is scheduled to reopen in September.
Bulverde	A full-price sales contract on the property has been received.
Cedar Park	The Anderson Mill access road MOU has been submitted to TXDOT for review.
Johnson City	HQ 1 st floor construction is in progress and Finance is expected to transition to the space in the fall. New HVAC units for the Moursund building's Control Room have been installed.
Leander	Our realtor has been engaged to develop a strategy to dispose of unwanted sections as we form a facility plan for the remainder of the site.
Marble Falls (Former district office)	In process of being prepared for use by the Safety and Training department.
Oak Hill	The warehouse furniture has been installed and currently waiting on septic permits. On schedule to open in the fall, if not sooner.
Spring Branch	The site has been cleared of excess vegetation to facilitate site-use and planning.
