This Membership Meeting is held in the Horseshoe Bay Resort, 200 Hi Circle North, Horseshoe Bay, TX and will be video recorded.

1. Registration and In-Person voting will begin at 8:00 AM, voting will close at 10:00 AM, and the business meeting will begin at 10:00 AM. Activities and exhibits, 8:00 AM-10:00 AM.

At 10:03 am President Paul Graf welcomed everyone to the 2019 Annual Meeting, announced that voting booths had closed, and stated that the activities and exhibits were also closed. President Paul Graf asked everyone to be aware of exit locations in case of an emergency and thanked the security officers, local police officers, and officers from the Llano County Sheriff's Department for their service to the community and presence at this meeting.

2. Call to Order and Roll Call

At 10:03 am President Paul Graf called to order the meeting of the members at the Horseshoe Bay Resort, 200 Hi Circle North, Horseshoe Bay, TX.

6. Approve Minutes of 2018 Annual Membership Meeting

President Graf stated that without objection from the members, the reading of

the minutes would be dispensed. Copies of the minutes were provided. There being no objection, President Graf stated that without objection, the 2018 meeting minutes were approved.

7. President's Report

During the President's Report, President Graf noted that in 2018, PEC celebrated its 80th Anniversary, and the Cooperative experienced 4.9% annual growth, added 14,617 meters, and had strong financials including revenues of \$638.5 million, and said Capital Credits of \$11.9 million was returned to members. He stated PEC had \$1.7 billion in assets and reaffirmed the AArating from Fitch Ratings. He reported that from July 2014 to January 2019, PEC rates were about 17% lower. Based on the Texas Public Utility Commission published numbers, PEC residential rates are more than 10% lower than Texans in the areas of competition. He said there was increased reliability, and PEC invested in Member Relations for improved JD Power scores, and that PEC started the Co-op Solar Program. He stated PEC experienced a full year under the guidance of CEO Julie Parsley. President Graf stated employees made service restoration and reliability one of Cooperative's key focal point. On the average each member experienced a service interruption lasting 54 minutes. There was a 6% improvement in reliability from 2017, and preliminary numbers for the last 12 months pointed to another significant improvement in 2019. He said PEC will continue to work to optimize and diversify our power supply needs, when it makes economic sense. He stated that \$0.57 of every dollar goes to power supply and will work to stay ahead of record growth and connect new services in a timely manner. The battery storage initiative project is active and the \$1.5 M grant from TECQ makes this \$3 M project financially beneficial to the PEC membership. He mentioned the Board asked for a Broadband Feasibility Study and it has commenced.

President Graf closed saying PEC had an outstanding year in 2018, and 2019 is shaping up to be as good, or even better. The future for PEC, its employees, and the membership is very bright.

8. CEO's Report

Chief Executive Officer (CEO) Julie Parsley presented the Chief Executive Officer Report, stating her first year as CEO marked a year of growth, resiliency, and achievement. Ms. Parsley recognized the Executive Team for the support and guidance and thanked them for the remarkable experience, dedication, and hard work moving the cooperative into the future.

CEO Parsley said the cooperative principle of "Concern for Community" is doing what is best for members. Ms. Parsley discussed the record growth across the service territory, and expanding and upgrading the infrastructure in anticipation of even more growth. She discussed the 2018 devastating flooding that severely affected members. PEC employees raised money, collected supplies, and donated time to help clean up the parks and riverbeds. CEO Parsley recognized the employee efforts and said she was proud of everything the employees put into the cooperative each day.

Ms. Parsley indicated PEC was ranked number 10 among all electric utilities in the nation -investor-owned and cooperatives - for overall customer satisfaction according to J.D. Power. In fact, PEC was the highest ranking electric utility in Texas. CEO Parsley mentioned the Power of Change Program, stating by rounding up electric bills each month, members can assist local nonprofits throughout the service territory.

CEO Parsley thanked the members for attending the meeting and said she was grateful for the members' support, and said we're here to support the members to work together to make the communities shine. CEO Parsley shared a short video highlighting some of the year's accomplishments, accolades, and events that brought the membership together and to make us PEC Strong.

9. Certificate of Secretary-Treasurer Regarding Member Quorum

Board Secretary-Treasurer Emily Pataki announced that based on the information provided, quorums were present to conduct the 2019 Membership Meeting and the Director District Elections, and that the certificates will be attached to the minutes.
